- who had received many complaints against. Almost all the candidates who could be disqualified have lodged appeals against the decision, said IEC officials.

"Some of the candidates whose names are dropped from the list could be reinstated on the list, some of the candidates who were issued warnings could have their warnings reversed and instead face disqualification," said the IECC's spokesman Ali Reza Rouhani.

"We expect that actions are taken in line with credible evidence and documents available; undoubtedly, there are some elements whether outside or inside government who want to interfere in this respect," said Mohammad Haroun Nusrat, a member of Transparent Election Foundation of Afghanistan (TEFA).

Meanwhile officials from the Independent Election Commission of Afghanistan (IEC) have said that the work of the IECC has not been carried out in line with the electoral calendar and that delays have had an impact on the IECC's performance.

"We need to prepare the (candidate) list from the beginning, we would need at least 35 days to send the list abroad for printing and bring them back and would need to pack them again and send them to the provinces; it means that this process would need time while we have very little time now. We hope that our colleagues in the electoral complaints commission study the calendar again if they have not studied it correctly; based on the calendar, these are the ones who are supposed to give us the list," said IEC commissioner Sayed Hafiz Hashemi.

Based on IEC statistics, over 2,300 candidates across Afghanistan have nominated themselves to run in the upcoming parliamentary elections scheduled for October 20.

The IECC's special commission started assessing about 200 complaints against hopeful candidates last month. The commission later changed its mechanism of assessment and assessed 137 complaints.

From 137 complaints, the commission disqualified 25 candidates and issued warnings to eight others.

Reports indicate that Fawzia Kofi, an MP from Badakhshan, Allah Gul Mujahid and Shir Ali Ahmadzai are among the 25 names removed from the list.

"They have made the allegations, but even a child knows the character of Mrs. Kofi. They want to impose political damage to me because of my resistance with the people. They have forgotten that this is not damage this is an honor for me," Fawzia Kofi said. "The complaints commission is not independent. They are doing what government orders them. This is unjust," Allah Gul Mujahid said. (Tolo news)

"The government has made us certain promises, the government has said that we will join the peace process, if the government wants, we will be hired," said Daesh commander, Mawlawi Habiburrahman.

When asked about human rights violations and reports of Daesh fighters having raped women and children in Darzab district, Mawlawi Habiburrahman said: "If someone comes up with evidence to prove this, we are prepared for the perpetrators to be served justice."

Darzab has been one of the most insecure districts in the province and has been the scene of heavy clashes in the past three years between government forces, Taliban and Daesh insurgents.

According to the Daesh commander, some foreign nationals - including two French fighters and two Indonesians have joined the Taliban.

"The Taliban came and took over our base, they burnt the houses and escaped and we surrendered to the government," said one Daesh fighter Abdul Qudoos.

In December, AFP quoting Afghan and international sources, reported that French and Algerian fighters, some arriving from Syria, had joined the ranks of Daesh in the northern Jawzjan province where the militant group had established a new base.

The report said that it was the first time that the presence of French Daesh fighters had been recorded in Afghanistan. At the time analysts also said they expect that foreigners may be heading for the war-torn country after being driven from Syria and Iraq. (Tolo news)

**Iran Guards says it held Gulf drills as U.S. tensions rise**

DUBAI - Iran's Revolutionary Guards confirmed on Sunday it had held war games in the Gulf over the past several days, saying they were aimed at "confronting possible threats" by enemies, the state news agency IRNA reported. U.S. officials told Reuters on Thursday that the United States believed Iran had started carrying out naval exercises in the Gulf, apparently moving up the timing of annual drills amid heightened tensions with Washington.

"This exercise was conducted with the aim of controlling and safeguarding the safety of the international waterway and within the framework of the program of the Guards' annual military exercises," Guards spokesman Ramezan Sharif said, according to IRNA. The U.S. military's Central Command on Wednesday confirmed it has seen increased Iranian naval activity. The activity extended to the Strait of Hormuz, a strategic waterway for oil shipments the Revolutionary Guards have threatened to block.

Guards commander Mohammad Ali Jafari "expressed satisfaction over the successful conduct of the Guards naval exercise, emphasizing the need to maintain and enhance defense readiness and the security of the Gulf and the Strait of Hormuz and to confront threats and potential adventurous acts of enemies," IRNA quoted Sharif as saying.

One U.S. official, speaking on condition of anonymity, said possibly more than 100 vessels were involved in the drills, including small boats.

U.S. officials, speaking to Reuters on condition of anonymity, said the drills appeared designed to send a message to Washington, which is intensifying its economic and diplomatic pressure on Tehran but so far stopping short of using the U.S. military to more aggressively counter Iran and its proxies. **Saleh Muhammad Wins NA-13 Mansehra after Recounting**

MANSEHRA - After seven days of recounting of votes in NA-13 Manshera, the PTI supported independent candidate once again won the general elections against PML-N candidate.

Saleh Muhammad Khan won the elections by securing 108850 votes while the PML-N candidate of Sardar group Sardar Shahjahan got 106688 votes.

Saleh Muhammad Khan was resident of NA-14 Mansehra but he contested elections from NA-13. During the previous general elections, he won Provincial Assembly seat on the ticket of PML-N, this time he resigned from PMLN and contested election independently in support of PTI. (Monitoring Desk)

**Iraq Election Commission Ignored Warnings over Voting Machines - Document**

BAGHDAD - Iraq's election commission ignored an anti-corruption body's warnings about the credibility of electronic vote-counting machines used in May's parliamentary election, according to investigators and a document seen by Reuters.

The devices, provided by South Korean company Miru Systems under a deal with the Independent High Elections Commission (IHEC), are at the heart of fraud allegations that led to a manual recount in some areas after the May 12 election.

The results of the recount have not yet been announced and political leaders are still trying to form a government.

Concerns about the election count center on discrepancies in the tallying of votes by the voting machines, mainly in the Kurdish province of Sulaimaniya and the ethnically-mixed province of Kirkuk, and suggestions that the devices could have been tampered with or hacked into to skew the result.

Iraq's Board of Supreme Audit (BSA) expressed reservations about the vote-counting system in a report it sent to the IHEC on May 9, three days before the election.

The BSA said in the report, seen by Reuters, that the IHEC had not responded to 11 concerns it had raised - including over contractual procedures, the inspection of company documents and a failure to properly examine the devices for any flaws.

"Hereby, we found that ignoring and not responding to the report's findings is considered a clear legal violation contributed to the passage of the electronic vote counting devices despite its unsuitability and easiness of being tampered," the BSA said in the report.

The report also referred to a letter from the Iraqi embassy in South Korea saying Miru Systems had assembled but not manufactured the equipment sent to Baghdad, and suggesting the price tag should have been lower.

The IHEC's failure to act on the report's findings could fuel calls for the election to be rerun, a concern for populist cleric Moqtada al-Sadr, leader of the political bloc that won on May 12.

A Miru official who spoke on condition of anonymity dismissed the assertion in the letter, saying the company had manufactured the equipment. He also said the "equipment does not lie" and that he and five other Miru employees had traveled to Iraq to examine the machines and found no evidence of hacking.

"We have checked our election device provided to Iraq after the fraud allegation erupted, and found out that there has been no malfunction in the device nor its system," he said.

"We have already submitted the report to Iraq's national election commission after making a thorough check on the device."

Sadr has expressed concern about the situation.

"There are fears that the recount process will be a preamble to repeat the election and infringe on people's votes. (Reuters)
